### **DEPARTMENT OF PUBLIC HEALTH TO OPEN VACCINE SCHEDULING LINKS**

The Monroe County Department of Public Health is preparing to open several vaccine scheduling links today. These links will be posted by 5 p.m. on the Monroe County website: <https://www.monroecounty.gov/health-covid19-vaccine>

#### **Individuals who are 60+ years of age and living in New York State**

MCDPH is scheduling appointments that start this week at the Monroe County Fleet Center, 145 Paul Rd., Rochester, 14624. On Thursday, MCDPH will be administering the Johnson & Johnson vaccine for individuals who are 60+ years of age. The Pfizer vaccine will be administered on other days this week.

#### **Phase 1B essential workers who are eligible in Monroe County**

MCDPH is scheduling appointments that start this week at the Rochester Riverside Convention Center, 103 E. Main St., Rochester, 14604. Please note that this week the County is administering the Pfizer vaccine, which is approved for individuals 16 years and older.

The following is a general list of essential employees who will be eligible to sign up using this link. For more detailed descriptions of these categories, please [visit this link](#).

- First Responder or Support Staff for First Responder Agency
- Corrections
- P-12 school (public or non-public)
- In-Person College Faculty and Instructors
- Employees or Support Staff of Licensed, Registered, Approved or Legally Exempt Group Childcare Settings
- Licensed, Registered, approved or legally exempt group Childcare Provider
- Public Transit
- Public Facing Grocery Store Workers, including convenience store and bodega workers
- Individual living in a homeless shelter where sleeping, bathing or eating accommodations must be shared with individuals and families who are not part of your household
- Individual working (paid or unpaid) in a homeless shelter where sleeping, bathing or eating accommodations must be shared by individuals and families who are not part of

the same household, in a position where there is potential for interaction with shelter residents.

**Individuals 18+ years old with comorbidities and underlying conditions**

MCDPH is scheduling appointments that start this week at the Rochester Riverside Convention Center, 103 E. Main St., Rochester, 14604. Please note that this week the County is administering the Pfizer vaccine.

Individuals must self-attest to having a comorbidity or underlying condition that makes them eligible. No doctor's note or other medical information is needed. Individuals using this link must attest to having one or more of the following comorbidities and underlying conditions:

- Cancer (current or in remission, including 9/11-related cancers)
- Chronic kidney disease
- Pulmonary Disease, including but not limited to, COPD (chronic obstructive pulmonary disease), asthma (moderate-to-severe), pulmonary fibrosis, cystic fibrosis, and 9/11 related pulmonary diseases
- Intellectual and Developmental Disabilities including Down Syndrome
- Heart conditions, including but not limited to heart failure, coronary artery disease, cardiomyopathies, or hypertension (high blood pressure)
- Immunocompromised state (weakened immune system) including but not limited to solid organ transplant or from blood or bone marrow transplant, immune deficiencies, HIV, use of corticosteroids, use of other immune weakening medicines, or other causes
- Severe Obesity (BMI 40 kg/m<sup>2</sup>), Obesity (body mass index [BMI] of 30 kg/m<sup>2</sup> or higher but < 40 kg/m<sup>2</sup>)
- Pregnancy
- Sickle cell disease or Thalassemia
- Type 1 or 2 diabetes mellitus
- Cerebrovascular disease (affects blood vessels and blood supply to the brain)
- Neurologic conditions including but not limited to Alzheimer's Disease or dementia
- Liver disease
