Please arrive at the WellNow Clinic that is highlighted on your authorization form as Your failure to keep this scheduled. appointment or complete the test as directed will be considered the same as a positive drug test result. You will be required to provide Photo Identification (Driver's License, Passport, Company ID, etc.). If you do not have photo identification, inform your Monroe County department contact at least 24 hrs prior to the test. If you arrive at the collection site without photo identification the collection will not take place and the result will be considered the same as a positive test result.

At the collection site you will be required to sign consent forms prior to the urine collection. You will be directed to remove any unnecessary outer garments; you will not be asked to disrobe or put on a hospital gown. All personal possessions, with the exception of your wallet, must be left with the technician. The technician will ask you to wash and dry your hands thoroughly before taking you to the collection room. Once in the collection room (usually a bathroom), you will be given a container to fill with urine; the urine collection WILL NOT be observed under ordinary circumstances.

After you have provided the urine sample to the technician you will be allowed to wash and dry your hands. The technician will take your sample and pour half of it into another container; this container is called "the split". Both containers are then sealed and sent to the laboratory. You will be required to observe and confirm the process of identifying your sample.

If the presence of a controlled or illegal substance is detected in your urine sample (a "positive" test result), a Medical Review Officer from WellNow will contact you. At that time, you will have the option to request that your "split" sample be tested at another lab, at your own expense.

In the event of a confirmed positive test result, your offer of employment will be rescinded and will be disqualified for employment with Monroe County for up to one (1) year.
