The following project was submitted for consideration by the Board:

Amend the 2021-2026 Capital Improvement Program and the 2021 Capital Budget to Add a Project Entitled "Energy Improvement Equipment Acquisition"

Bob Franklin, CFO, addressed the Planning Board on the action item before them. Mr. Franklin explained that the Energy Improvement project began in 2017 and included implementing energy saving measures such as LED lighting retrofits, electric to natural gas conversions, and steam to hot water conversions. At this time, NYPA is requiring a new finance agreement; however, it is in the County's best financial interest to bond for the project instead.

Mike Garland made a motion to recommend an amendment to the 2021-2026 Capital Improvement Program and the 2021 Capital Budget to add a project entitled "Energy Improvement Equipment Acquisition", in the amount of \$12,900,000. Joe Morelle, Jr. seconded the motion which passed unanimously.
