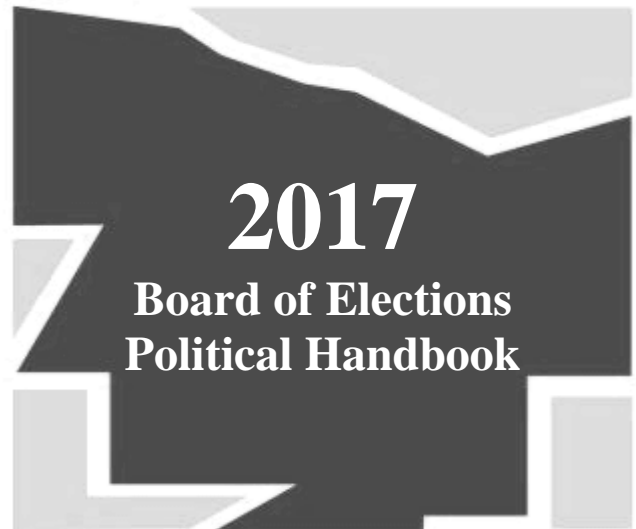

REGISTRATION AND ABSENTEE VOTING

REGISTRATION

A person may register if he/she is:

- 18 years of age by Election Day
- a United States citizen
- a resident of Monroe County for thirty days prior to the Election.
- not in jail or on parole for a felony conviction
- not claiming the right to vote elsewhere

MAIL REGISTRATION: Applications must be postmarked not later than October 13 and be received by the County Board of Elections not later than October 18 to be eligible to vote in the General Election.

IN PERSON REGISTRATION: You may register at your local Board of Elections or any state agency participating in the National Voter Registration Act, on any business day throughout the year but, to be eligible to vote in the November 7, 2017 General Election, your application must be received no later than October 13 except, if you have been honorably discharged from the military or have become a naturalized citizen since October 14, you may register in person at the Board of Elections up until October 28.

CHANGE OF ADDRESS: If currently registered, your notice of change of address must be received by the Board of Elections by October 18 to be processed and entered in the records for the General Election.

ABSENTEE VOTING

A voter is eligible for an absentee ballot in a Primary, Special or General Election if he/she is required to be absent from the County on that day because of duties, occupation, business or vacation or if he/she will be confined by illness on either a temporary or permanent basis. An application for an absentee ballot may be obtained from the Board of Elections.

Signed applications for an absentee ballot must be postmarked to the Board of Elections no later than seven days prior to the Election. Absentee ballots for a Primary, General or Special Election, if postmarked no later than the day prior to the Election, will be accepted if received at the Board of Elections within seven days after the Election. A person whose illness or physical disability commences within ten days prior to Election Day may make signed application to the Board of Elections through **5 P.M.** on the day prior to the Election. A person called out of the county after the deadline for an absentee application may apply **in person** at the Board of Elections through **5 P.M.** on the day before the Election.

- August 23 **Changes of address** for Primary received by this date must be processed. §5-208(3)

VOTER REGISTRATION FOR GENERAL

- October 13 **Mail Registration for General:** Last day to postmark application for general election and last day it must be received by board of elections by Oct. 18. §5-210(3)
- October 13 **In person registration for General:** Last day application must be received by board of elections to be eligible to vote in general election. If honorably discharged from the military or have become a naturalized citizen since October 13th, you may register in person at the board of elections up until October 28th. §§5-210, 5-211, 5-212
- October 13 **Change of Party Enrollment:** Last day to accept a change of enrollment. Election Law Title III, §5-304(3)
- October 28 **Changes of address** for General received by this date must be processed. §5-208(3)
