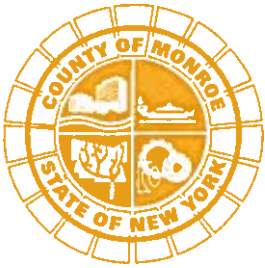

Subject: Approve Agreement Between the Monroe County Executive and the Civil Service Employees Association, Part-Time Unit 7401

Honorable Legislators:

I recommend that Your Honorable Body approve the agreement between the Monroe County Executive and the Civil Service Employees Association, Part-Time Unit 7401, for the period of January 1, 2015 through December 31, 2019.

The agreement was ratified by the Union membership on May 11, 2015. The principal terms of this agreement are outlined below:

The salary schedule for this unit will continue to be frozen for the life of the agreement. Commencing June 1, 2015, Unit members will be eligible for step movement every other year. Employees at the top of the pay scale for at least 12 months will receive a wage increase as follows:

- 1% wage increase on June 1, 2015
- 2% wage increase on January 1, 2016
- 1% wage increase on January 1, 2017
- 2% wage increase on January 1, 2018
- 1% wage increase on January 1, 2019

The estimated cost of this referral is:

2015	\$ 12,379.75
2016	\$ 48,336.31
2017	\$ 66,674.15
2018	\$103,716.60
2019	\$122,608.25

The specific legislative action required is to approve the agreement between the Monroe County Executive and the Civil Service Employees Association, Part-Time Unit 7401, for the period of January 1, 2015 through December 31, 2019.
