

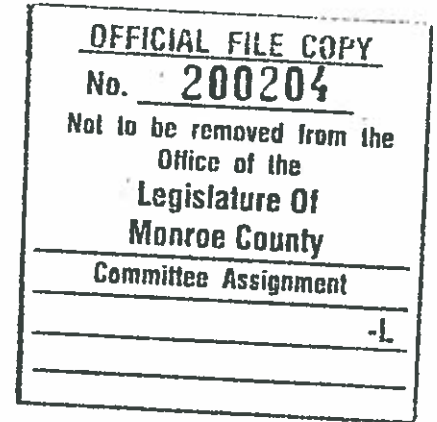

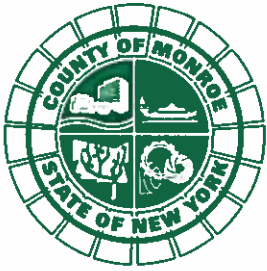

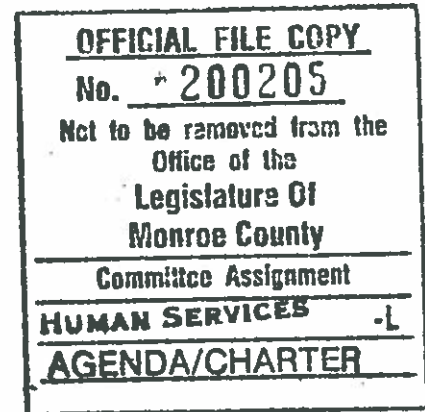

Subject: Enacting a Local Law Requiring Pharmacies to Provide Notice on the Availability of Naloxone

Honorable Legislators:

In 2019, Monroe County lost 127 residents to an opioid overdose. While our community has made significant efforts to support residents battling opioid addiction, we must continue to remove barriers to treatment and end the stigma associated with this public health crisis.

Opioid antagonists, such as naloxone/Narcan, are effective in neutralizing the effects of an opioid overdose. According to one report on naloxone dosages given by New York State law enforcement officers from 2014 to 2017, 88% of individuals who received naloxone during an opioid overdose survived. Over 100 pharmacies in Monroe County provide this life-saving medicine without a prescription through standing orders pursuant to New York State Public Health Law. It is crucially important that we ensure that the public is made aware that this resource is available to them. Individuals that need or support those who need naloxone may not know this resource is available or may not want to inquire with a pharmacist due to perceived stigma associated with opioid use.

To promote the health and well-being of individuals residing in Monroe County, I propose that this Honorable Body adopt a local law requiring pharmacies in Monroe County that provide naloxone to alert the public that this medicine is available without a prescription. Rather than requiring individuals to request naloxone or other opioid antagonists, the proposed local law would require pharmacies to provide naloxone whenever they first fill an opioid prescription for a customer, unless the customer opts out of receiving naloxone.

**The specific legislative actions required is to adopt a local law requiring pharmacies in Monroe County that carry opioid antagonists to provide naloxone or another opioid antagonist to a customer whenever they first fill an opioid prescription for a customer, unless the customer opts out of receiving naloxone or another opioid antagonist.**

This local law will have no impact on the revenues or expenditures of the current Monroe County budget. The provisions of the New York State Environmental Quality Review Act shall be complied with prior to this Honorable Body undertaking, funding, or approving the action requested in this referral.

I recommend that this matter be referred to the appropriate committee(s) for favorable action by this Honorable Body.

LOCAL LAW NO. \_\_ OF 2020

**ENACTING LOCAL LAW ENTITLED “PHARMACIES TO PROVIDE NOTICE ON THE AVAILABILITY OF NALOXONE”**

BE IT ENACTED BY THE LEGISLATURE OF THE COUNTY OF MONROE, as follows:

Section 1. Legislative Intent. While our community has made significant efforts to support residents battling opioid addiction, we must continue to remove barriers to treatment and end the stigma associated with this public health crisis.

Opioid antagonists, such as naloxone/Narcan, are effective in neutralizing the effects of an opioid overdose. Over 100 pharmacies in Monroe County provide this life-saving medicine without a prescription through standing orders pursuant to New York State Public Health Law. It is the intent of this local law to ensure that the public is made aware that this resource is available to them.

Section 2. Definitions. The following terms used in this local law shall have the meanings indicated:

1. “Opioid” means an opiate as defined in section 3302 of the Public Health Law.
2. “Opioid antagonist” means a drug approved by the Food and Drug Administration, that, when administered, negates or neutralizes in whole or in part the pharmacological effects of an opioid in the body. An opioid antagonist is limited to naloxone or other medications approved by the New York State Department of Health for this purpose.
3. “Pharmacy” means a pharmacy registered in accordance with Article 137 of the New York State Education Law.
4. “Standing order” means a non-patient specific prescription to dispense an opioid antagonist to a consumer.

Section 3. Pharmacies to Provide Opioid Antagonists with the Dispensation of an Opioid.

1. All pharmacies within Monroe County that maintain a standing order must provide at least one (1) dose of an opioid antagonist to each individual to whom it dispenses an opioid unless such individual opts-out, in writing, from receiving an opioid antagonist.

2. The provisions of this local law shall not limit the authority of a health care professional to prescribe, dispense or distribute, or of a pharmacist to dispense, an opioid antagonist under any other provision of local, state, or federal law.

Section 4. Severability. If any clause, sentence, paragraph, subdivision, section, or part of this law or the application thereof to any person, individual, corporation, firm, partnership, entity, or circumstance shall be adjudged by any court of competent jurisdiction to be invalid or unconstitutional, such order or judgment shall not affect, impair or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, section or part of this law, or in its application to the person, individual, corporation, firm, partnership, entity, or circumstance directly involved in the controversy in which such order or judgment shall be rendered.

Section 5. Effective Date. This local law shall take effect in accordance with the provisions of the Municipal Home Rule Law and the Monroe County Charter.

**Re: Memorializing Governor Andrew M. Cuomo to Immediately Include the Opening of Malls and Enclosed Shopping Centers in Phase 2 of New York's Reopening Plan**

Honorable Legislators:

Our community's response to the COVID-19 pandemic has been collaborative, disciplined, and effective. Social distancing measures and the implementation of safety plans have helped flatten the curve and stop the spread of the novel Coronavirus in such a way that we are beginning to see businesses reopen in our area. While I appreciate the cautious reopening for the health of our residents, certain types of businesses, including malls and enclosed shopping centers – with the exception of stores with exterior entrances – have been left out of early reopening phases to the detriment of our economy.

Guidance from New York State for in-store retail in Phase 2 of the Reopening Plan calls for 50% maximum occupancy of retail stores, face coverings for employees and shoppers, use of curbside shopping when possible, controlled foot traffic using signage and markers, and the closing of shared amenities. Most, if not all, shopping malls also have large lobbies and hallways to ensure social distancing is maintained. All of these measures can be implemented in malls and enclosed shopping centers and many were prepared to do so before Governor Cuomo made last minute changes to the requirements of Phase 2, deeming shopping centers ineligible to open during this phase.

The economic implications of COVID-19 have been unprecedented and severe; since the onset of the pandemic, the unemployment rate has drastically increased with millions of businesses having been forced to shut their doors indefinitely. Malls and the stores inside them employ full-time and part-time employees who have been out of work for months due to the COVID-19 pandemic. These employees are ready and able to return to work to serve customers following proper guidance.

Unemployment is just one component of the economic impact that is being experienced as a result of the COVID-19 pandemic. Local governments, including Monroe County, are expecting to face major sales tax revenue shortfalls as a result of the COVID-19 pandemic. Monroe County is posed to face a sales tax revenue shortfall in the millions; in April, Monroe County saw a 25% decrease in sales tax revenue as compared to 2019. Sales tax revenues make up a significant amount of the budget in local municipalities and seeing a drastic drop could adversely impact taxpayers. Area malls are a large driver of sales tax revenue for local governments and their reopening immediately would be a promising step in revitalizing the economy in Monroe County, as well as other communities throughout New York State.

Over the past weeks and months, we have worked together, learning how to adapt to a new normal way of life. Our community has united to find new, creative ways to keep ourselves and each other safe during these unprecedented times. It is time to continue this response to help our family, friends, and neighbors return to work as quickly and safely as possible and to aid in the revitalization of our local economy. Changing the parameters under which malls and enclosed shopping centers are able to reopen further stifles economic progress we should be making at this time and is damaging to our entire community. Therefore, I urge you to join me in calling on Governor Andrew M. Cuomo to immediately include the opening of malls and enclosed shopping centers in Phase 2 of New York's Reopening Plan as originally intended.

**RE: Memorializing the NYS Legislature to Pass and Governor Andrew Cuomo to Sign Legislation to Repeal or Amend Section 50-a of the Civil Rights Law.**

Honorable Legislators,

Officer Derek Chauvin had nearly 20 complaints filed against him before he killed George Floyd. Prior to killing Eric Garner with the use of an illegal choke hold, Daniel Pantaleo had seven disciplinary complaints and 14 individual complaints filed against him. Four of those allegations were substantiated by an independent review board – an alarming fact given how rare it is for a police officer to have more than one complaint upheld by that independent board.

These revelations raise serious questions about the disclosure of allegations and findings of misconduct on the part of police officers. In New York State, like many others states with similar laws, Section 50-a of New York State Civil Rights Law allows police departments across the State to prevent the disclosure of records of misconduct. When the Legislature passed 50-a in 1976, the intention was to protect police witnesses from improper cross examination. A report on Assembly bill A.333 produced by a legislative committee of the New York City Bar Association notes that the chief sponsor of the law, former New York State Senator Padavan, never intended the law to block disclosure of police misconduct from the public. Instead, the report notes, Senator Padavan made clear in the bill jacket, that his intent was to prohibit the release of “unverified and unsubstantiated” civilian complaints—not to bar the release of substantiated civilian complaints. However, since that time, the use of 50-a has expanded to cover nearly every police personnel record. As a result, it has become almost impossible for the public to know the extent of an officer’s misconduct and how that misconduct has been addressed.

In the wake of George Floyd’s killing at the hands of an officer with multiple complaints, it is time New York State join the 12 states (Alabama, Arizona, Connecticut, Florida, Georgia,



Maine, Minnesota, Ohio, North Dakota, Utah, Washington and Wisconsin) in which police disciplinary records are made available. Concerns about the propriety and safety and security of public employee personnel records are already addressed under New York States Freedom of Information Law (FOIL). FOIL protects the disclosure of documents that would constitute an unwarranted invasion of an individual's privacy and exempts the disclosure of information that would jeopardize the life, safety and security of any person.

Therefore, we respectfully urge you to join us in memorializing the NYS Legislature to pass, and Governor Andrew Cuomo to sign legislation to repeal or amend Section 50-a of the Civil Rights Law.

Honorable Legislators:

I recommend that Your Honorable Body authorize an Amended and Restated Traffic Signal Easement and Agreement with GM Components Holdings, LLC, for Monroe County to perform traffic signal operation and maintenance services for Traffic Signal #535, located at the intersection of Lexington Avenue and GM Components Holdings in the City of Rochester, for an estimated annual amount of \$970, with escalations to be limited to an amount equal to the increase in the previous year's Consumer Price Index (U.S. City Average CPI-U from the Bureau of Labor Statistics).

Lexington Avenue is a City of Rochester public street. A private driveway serving the parking lot for GM Components Holdings intersects with Lexington Avenue at an existing traffic signal that is operated and maintained by the Monroe County Department of Transportation. The existing traffic signal easement and agreement with the prior owner of the property, Delphi Automotive Systems LLC, allowed for the County to operate and maintain the traffic signal, but did not specify the costs to be reimbursed by the property owner. This Amended and Restated Traffic Signal Easement and Agreement with GM Components Holdings, LLC will continue the existing arrangements, but provide for GM Components Holdings, LLC to reimburse the County for said services at an estimated amount of \$970 per year.

The specific legislative action required is to authorize the County Executive, or his designee, to execute an Amended and Restated Traffic Signal Easement and Agreement, and any amendments thereto, with GM Components Holdings, LLC, for Monroe County to perform traffic signal operation and maintenance services to traffic signal #535 located at the intersection of Lexington Avenue and GM Components Holdings in the City of Rochester, for an estimated annual amount of \$970, with escalations to be limited to an amount equal to the increase in the previous year's Consumer Price Index (U.S. City Average CPI-U from the Bureau of Labor Statistics).

This action is a Type II Action pursuant to 6 NYCRR § 617.5(c) and is not subject to review under the State Environmental Quality Review Act.

This agreement is revenue generating and no additional County support is required in the current Monroe County budget.



I recommend that Your Honorable Body accept a grant from Health Research, Inc., in the amount of \$495,860, for the Public Health Emergency Preparedness Program, for the period of July 1, 2020 through June 30, 2021, and authorize a contract with the University of Rochester, in an amount not to exceed \$24,500, for continuing development and sustainment of the County's Medical Countermeasure Program, for the period of March 16, 2021 through June 30, 2021.

The purpose of this grant is to assist local health departments to develop emergency-ready public health departments in accordance with the National Preparedness Goals and the Centers for Disease Control and Prevention Preparedness Goals. Program objectives are: continued COVID-19 response support, enhanced public health emergency preparedness including training, planning, equipment acquisition and response readiness; enhanced point of dispensing clinic readiness to include bioterrorism response (e.g. anthrax); expansion of a volunteer medical reserve corps; enhanced communicable disease planning (e.g. pandemic influenza); and enhanced disease surveillance. This will be the nineteenth year the County has received this grant. This year's funding represents the same amount as last year. An additional \$200,000 in restricted New York State Department of Health emergency placeholder funding is included. This funding could be made available in the event an actual public health emergency occurs during the grant period.

This contract will support the County's Medical Countermeasure Program. The University of Rochester will provide: support of exercise and drill development and implementation; communication and information management activities; Monroe County Department of Public Health staff and partner training; and completion of other related projects and activities as determined by the Program Manager of the Office of Public Health Preparedness.

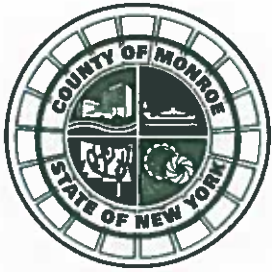

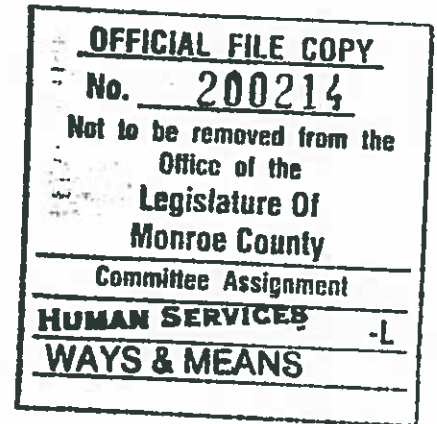

Subject: Acceptance of a Grant from the New York State Department of Health for the Drinking Water Enhancement Program

Honorable Legislators:

I recommend that Your Honorable Body accept a five-year grant from the New York State Department of Health, in an amount not to exceed \$693,055, for the Drinking Water Enhancement Program, for the period of April 1, 2020 through March 31, 2025.

The purpose of this grant is to enhance local drinking water programs and to provide increased oversight of public and private water supplies in Monroe County, along with ensuring continued compliance with the Federal Safe Drinking Water Act and the New York State Sanitary Code. An allocation formula based on population and the number of public water supplies provides the basis for funding for each local health department. Specific tasks and activities to be performed by the Monroe County Department of Public Health will include water system inspections, plan review, data evaluation, regulatory oversight, and water quality surveillance. Funds will be used to purchase supplies, cover travel expenses and support existing positions in the program. This will be the twentieth year the County has received this grant. This year's funding level is the same amount as the previous 12 month period.

**The specific legislative actions required are:**

1. Authorize the County Executive, or his designee, to accept a \$693,055 grant from, and to execute a contract and any amendments thereto with, the New York State Department of Health, for the Drinking Water Enhancement Program, for the period of April 1, 2020 through March 31, 2025.
2. Amend the 2020 operating budget of the Department of Public Health by appropriating the sum of \$138,611 into general fund 9300, funds center 5806010000, Environmental Health Administration.

3. Authorize the County Executive to appropriate any subsequent years of the grant award in accordance with the grant terms, to reappropriate any unencumbered balances during the grant period according to the grantor requirements, and to make any necessary funding modifications within the grant guidelines to meet contractual commitments.
4. Should funding of this program be modified or terminated for any reason, the County Executive is hereby authorized to terminate or modify the program and, where applicable, to terminate or abolish some or all positions funded under such program. Any termination or abolishment of positions shall be in accordance with New York State Civil Service Law and, when applicable, the terms of any labor agreement affecting such positions.

This grant is 100% funded by the New York State Department of Health. No additional net County support is required in the current Monroe County budget.

Honorable Legislators:

I recommend that Your Honorable Body authorize a contract with the University of Rochester, in an amount not to exceed \$41,500, for support of the Forensic Pathology Fellowship Program at the Monroe County Office of the Medical Examiner, for the period of July 1, 2020 through December 31, 2020.

Under the terms of this contract, the Office of the Medical Examiner (OME) will provide a one-year fellowship term for one physician seeking board examination eligibility. During the rotation, the knowledge and skills of the fellow, selected by the OME from candidates vetted by the University of Rochester and then maintained under the University of Rochester Human Resources and Graduate Medical Education Departments, will be enhanced and expanded through this additional education in the specialized field of forensic medicine. The fellowship will provide opportunities to learn, in part, about the Coroner and Medical Examiner system in New York State, the principles of death certification and the role of forensic disciplines. Additionally, at the completion of the fellowship program, the fellow would be eligible for the Forensic Pathology Board Certification Examination. The fellowship program is twelve (12) months in length and the actual program end date is June 30, 2021. It is anticipated that a subsequent request for authorization through June 30, 2021 will be made at the end of 2020.

To establish the fellowship, OME must partner with an institution that offers Graduate Medical Education Programs in the closely related field of Medical Clinical Pathology. It has been determined that the University of Rochester is a sole source provider for the Forensic Pathology Fellowship Program.

**The specific legislative action required is to authorize the County Executive, or his designee, to execute a contract, and any amendments thereto, with the University of Rochester, 601 Elmwood Avenue, Rochester, New York 14642, for support of the Forensic Pathology Fellowship Program at the Monroe County Office of the Medical Examiner, in the amount of \$41,500, for the period of July 1, 2020 through December 31, 2020.**


